Subject: Concerns Regarding CLW CCS Ltd. Election during Secondary Board Examination Period

Sir,

In response to your letter dated 28th January 2025 regarding the election of CLW CCS Ltd., which is scheduled for 12th February 2025.

As you are aware, the secondary board examinations followed by Higher secondary Examinations are set to commence from 10th February 2025 and afterwards consecutively. We have received requests from various associations involved in the election seeking permission to hold meetings during this period. However, we believe that organizing such meetings could disrupt the peaceful environment of the city and may lead to significant inconvenience for the secondary examinees, who will be preparing for and sitting their examinations.

Considering the sensitive nature of the examination period and the need for maintaining a quiet and focused atmosphere, we are concerned that these election meetings may cause unnecessary disturbances, leading to objections from students and their families.

Moreover, given the busy schedule and additional security demands during this time, we regret to inform you that we will not be able to provide the necessary security arrangements for any election-related meetings during the board examination period.

In light of these circumstances, I suggest that the CLW CCS Ltd. Election date should be reconsidered or rescheduled to a later date to ensure the smooth conduct of the board examinations followed by Higher Secondary Examinations and to maintain public order in the area.
